

Three roundtable discussions, Spring 2023

- What are the key challenges for integrated sustainability implementation?
 - Experts from nearly all ministries, including chief secretaries
- Where are the major knowledge gaps what science has to offer?
 - Government experts and science representatives
- How to synthesize the outputs to the chief secretaries committee
 - Core team (1person/ministry) of sustainability thinking



Our messages for government programme

- 1. Government programme to have **only few key goals**, potentially shared **mission for sustainability**
- 2. Key activities of the government to include sustainability assessment and monitoring
- 3. Strengthening of **capacities (expertise and resources)** on sustainability and impact assessment
- 4. Defining and strengthening the **knowledge base for social sustainability** to ensure balanced sustainability assessments
- Good governance and performance management to support sustainability thinking

Societal sustainability assessment





We are living historically exceptional times due to the global ecological crisis



Human activities are connected to all systems of the planet. Due to this, disturbances in earth systems lead to major direct and indirect crises in human societies, socially and individually.

To manage this, public and private resources need to be targeted more cost-effectively on investments which strengthen the holistic sustainability of our society.

Sustainability assessment helps to identify leverage points, to push forward a system level societal transformation and to build up societal resilience.



Societal sustainability assessment

- Produces annual review on the current state of holistic sustainability and possible developments in it, to support Government's decision making
- Produced by the Prime Minister's Office, in collaboration with other ministries. Reviewed by sustainability panel.
- Globally first governmental initiative on holistic sustainability assessment to inform budgeting

Holistic sustainability is analysed from five dimensions

Social and health sustainability Economic Sustainability of safety, Sustainability of human and cultural state of law sustainability and democracy capital **Ecological sustainablity**

Boundaries of each sustainability dimension are derived from the constitution or other laws or official targets

Holistic sustainability is balanced when all dimensions are in balance



Themes were selected from their scale, budget link, expected urgency and present role in strategic documents

In the sustainability assessment, each theme will be analysed through 2-3 focus areas to elucidate the challenging points and their state of sustainability





Current state and potential developments up to 8 years forward to be analysed for each theme



Using five dimensions of sustainability

End result: synthesis of the holistic sustainability (all dimensions)

- Current situation picture and 8 years from now
- Assessment of each dimension and each theme
- Assessment of interlinkages (themes, sustainabilities)
- Overall synthesis
