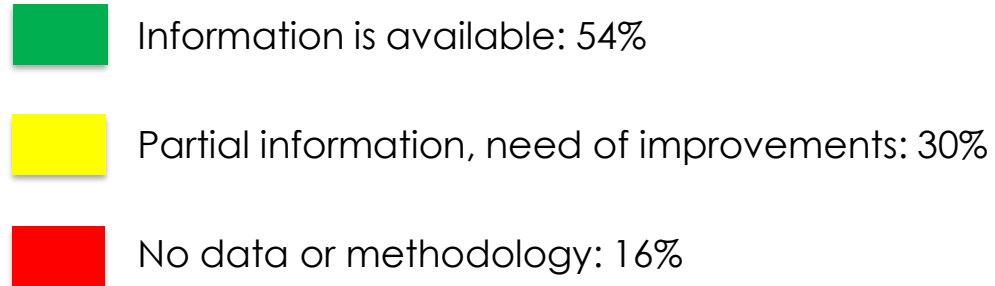

1. ACHIEVEMENT: NATIONAL INDICATORS

- Prioritization of indicators to include in a Policy Document (CONPES)

1. CHALLENGE: IMPROVE INFORMATION AVAILABILITY

Plan for statistical strengthening and strategies to use alternative sources

- With the support of the UN System, the Colombian Government is designing a project that seeks to generate tools to develop statistical capacities in the territories, allowing them to produce, disseminate and use information for the design and evaluation of policies and the decision making as support to reach the SDGs.
- Additionally, the UN Agencies in Colombia will support the definition or improvement of methodologies for 55 indicators.

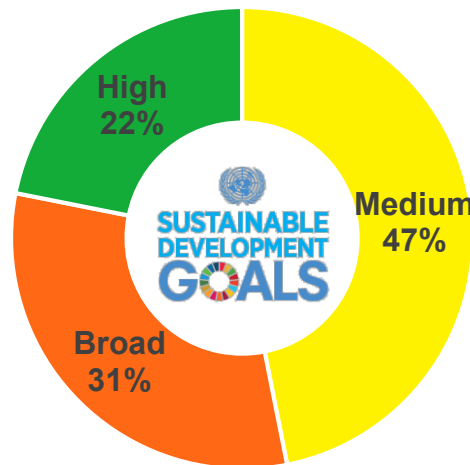
2. ACHIVEMENT: SDGs AND SUBNATIONAL DEVELOPMENT PLANS



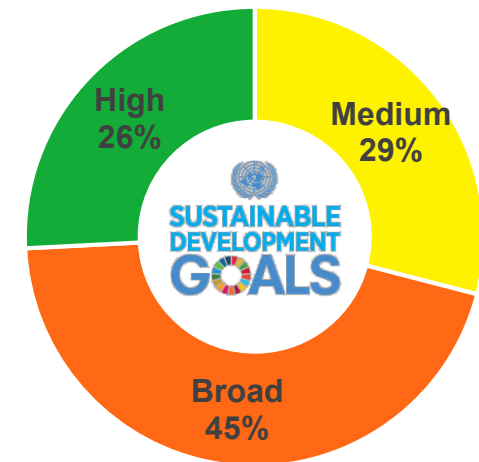
63 SUBNATIONAL DEVELOPMENT PLANS (SDPs) – 2016/2019

- **100%** of Local Development Plans included SDGs in policy framework
- **32 Regional:** high (7), medium (15) and broad (10)
- **31 Main Cities:** high (8), medium (9) and broad (14)
- On average, SDPs include 30% of SDG targets in which subnational governments have shared responsibility (33/110)

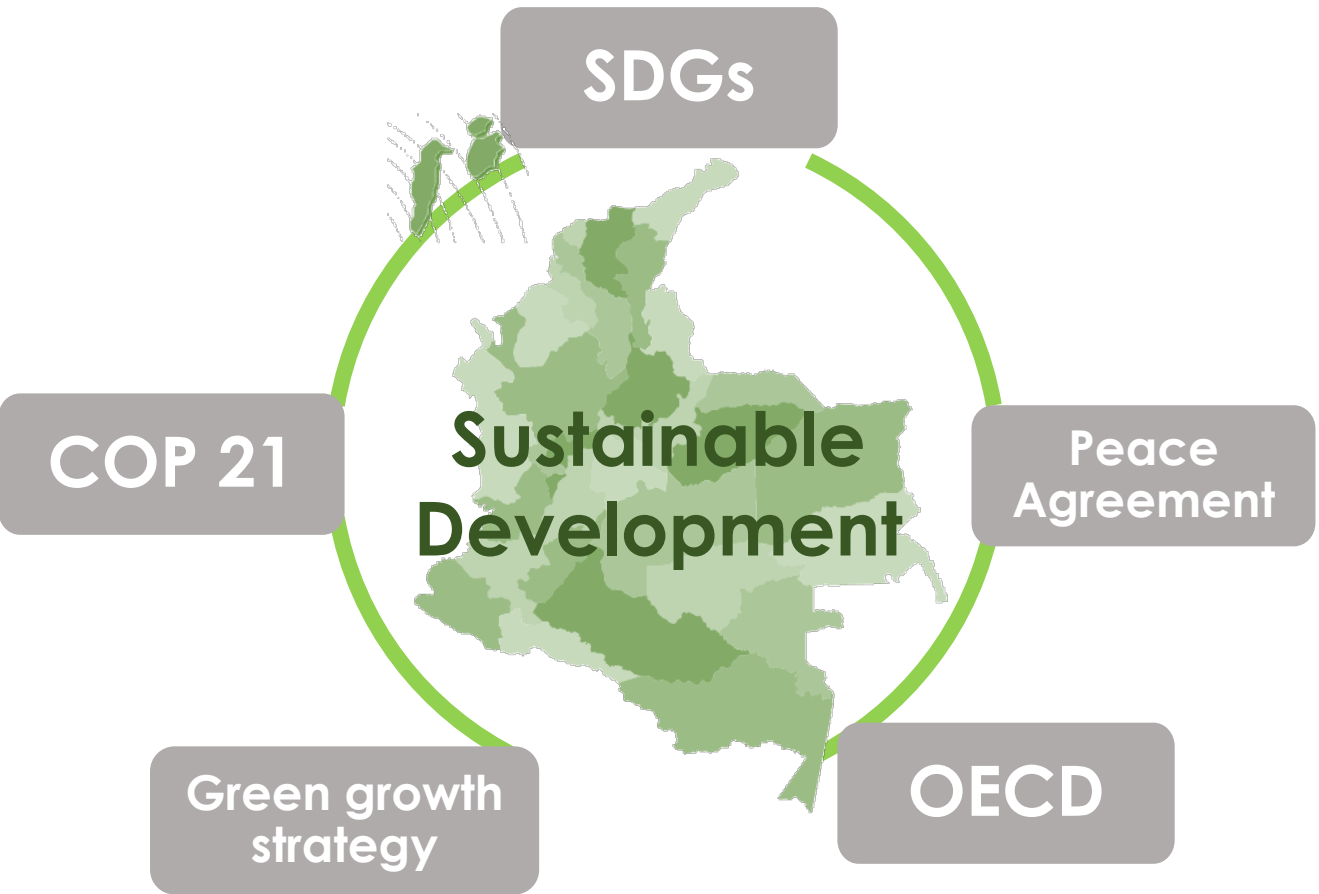

3. ACHIVEMENT: ALIGNMENT OF SDGs AND OTHER NATIONAL AGENDAS



- Peace Agreement: 68 targets
- OECD membership: 87 targets
- COP21: 18 targets
- Green Growth Strategy: 86 targets
- National Development Plan: 92 targets

3. CHALLENGE: LONG-TERM POLICY FRAMEWORK



Four Policy Guidelines built from lessons learned during MDGs implementation:

- Monitoring and Reporting framework
- Statistics strengthening plan
- Territorializing strategies
- Participation of non-governmental stakeholders

4. ACHIVEMENT: DESIGN OF A MECHANISM FOR THE INVOLVEMENT OF NON-GOVERNMENTAL STAKEHOLDERS

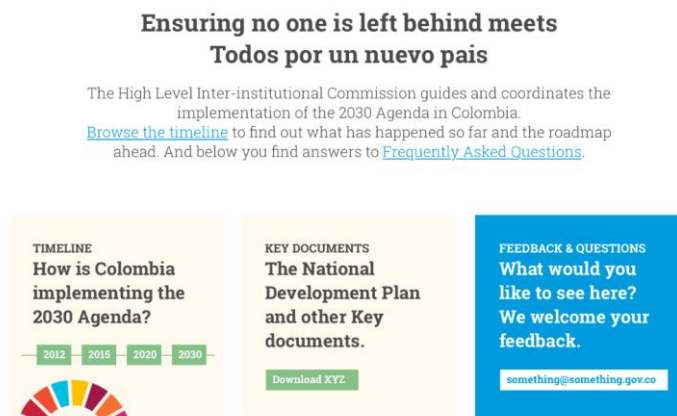
The participation of civil society will focus on the following aspects:

- **Mobilization and social appropriation of Agenda 2030 and its SDGs:** The objective is to generate ownership and mobilization of citizenship, contributing substantially to the effective implementation of the Agenda.
- **Contribute directly to the effective implementation of the SDGs:** Including the mapping of its contribution.
- **Production of information:** Civil society organizations can help fill gaps.
- **Social control:** Civil society can be involved in monitoring the achievement of defined goals.

The agenda will be thematically organized around the SDGs prioritized for the VNRs.

4. CHALLENGE: WORK TOWARDS THE PARTICIPATION OF ALL STAKEHOLDERS

- Pilot project to measure the **contribution of the private sector** to the SDGs in four cities (Bogotá, Cali, Medellín, Barranquilla) using information from sustainability reports.
- Four **regional meetings** with civil society organizations taking place the second semester of 2017.
- **Web portal:** Dashboard with information per SDG and target, including regional disaggregation, and SDGs implementation related information. With the support of the Government of Sweden.
